**Cancellations:** Once issued, the Park Use Permit is non-refundable. In the event of rain, the Community Services Department will re-issue the Park Use Permit with a change of date.

**Transfers:** Transfer requests made more than 30 days of the scheduled event will be subject to a \$10 processing fee. Transfer requests made between 15 and 30 days of the scheduled event will be subject to a processing fee equal to 50% of the total permit cost. Transfer requests are not permitted if made less than 15 days prior to the scheduled event.
