## 5. HEARINGS

5a. Project No. 2021-34 (Marks) – Consideration of a request to designate the property located at 7256 West Point Avenue, APN 469-551-16-00 in the R1 (Urban Residential) zone as a historic landmark and to establish a property preservation (Mills Act) agreement for the site

Ms. Kinnard presented the staff report.

The public hearing was opened.

Mr. Wallace requested that Criteria D (work of a master architect) be added to the recommendation as the home was designed by architect Lavina Colgan. Ms. Kinnard recommended that it be considered.
